#### **What is Community Supported Agriculture?**

CSA is a system of food distribution based on trust between the member and the farmer. By making your purchases in advance, you ( the member ) provide us with working capital and a guaranteed market for our produce. We will, in turn, provide you with the produce of your choice, grown to the best of our ability. Because you will provide a guaranteed market for us , we can offer a discount to you. The members and the farmers become partners in caring for our small family farm.

#### **Who We Are: A Tale of Two Farmers**

We both were raised in nearby Williamstown and come from several generations of Williamstown farm families. In 1984 after searching for a place to raise our family we came to Pownal and began to homestead. Homesteading turned into market gardening on a large scale when we recognized a growing need in our community for fresh local organic produce. In 1989 Wildstone Farm became the first farm in Bennington County to become certified organic. Consider joining us in 2022 as we proudly celebrate our 38th year here in Pownal and our 33rd year of organic certification by Vermont Organic Farmers. Since 2020, Wildstone Farm is also certified organic by The Real Organic Project.

#### **Our Farmers' Market Share CSA at Wildstone Farm**

Our Farmers' Market Share CSA uses a debit-style system. As a member you can purchase a share, the size that is convenient for you, which is redeemable for whatever we sell at the Bennington Farmers' Market. Your account is updated with each purchase. We ask that shares be fully redeemed by year's end; we will not carry balances over into the next calendar year.
